

Stephen's Box: About Volume 14 Beginning on page 23 below, the genealogical portion of this issue of "Among Cousins" is given over entirely to a reprisal of the known information about descendants of William Bland (C1748-1816) of New Hanover/Duplin County North Carolina and his two sons, William Bland (C1771-1854) and James Bland (C1772-1818) both of Duplin County North Carolina. This family was previously discussed in VU, pp. 293-320.

The decision to undertake a major revision of this family's history sprang from a number of simultaneous inquires from descendants including Milton Bland, Oldsmar Florida, Robert Russell Bland, Upton Massachusetts, A. Clarke Blanton, Westfield New Jersey, Susie Maus, Winchester Tennessee, Willie Moseley, Stateboro Georgia, Karen Roberts, Deland Florida, Gail Youmans Stokes, Blackshear Georgia and Frances Toth, Jacksonville North Carolina. In the course of Spring 1998, some of these cousins made inquiries, most contributed new information that helped tremendously. Most importantly, however, was the renewed acquaintance with Stephen McLeod of Tallahassee Florida. In 1982, while I was writing A Vision of Unity, Stephen was recommended to me by William Graham Bland as a 16 year old "wunderkind". The material Stephen sent me then and the acuity of his insights literally blew me away then. Much of the portion of the book dedicated to the Blands of Duplin County North Carolina was attributable to Stephen's research. Little did I know that I hadn't seen anything yet.

The reappraisal began as an anticipated half of the current volume, based on scraps and fragments I had received over the years. Then I wrote to several of the key correspondents and sent them a draft of a revision I had done, asking for comments. In

process, I reestablished contact with Stephen. He told me he was just too busy to make detailed comments to my draft, but offered to send me all his collected material in a big box, which arrived about the end of April. Stephen's box is a genealogist's equivalent of winning the Kentucky Derby, New York Lottery and Irish Sweepstakes enroute to Heaven. All I can say is Glory be! Never in my twenty years of research on the Bland family have I encountered a cache even remotely as rich and rewarding. After reading this issue, those who descend from this family will recognize its outlines, but also that it is no longer the same family history. Those who are not of this line, but love the Bland Family as I do, also will recognize and rejoice at the tremendous importance of what has happened with this issue, how significant it is that there has been so much to add about this family.

I am grateful for the opportunity to bring out this new information, but I am only the collator. The true credit goes to young Stephen McLeod (time marches on for us all and Stephen is now a young man in his early thirties). It also goes to all those cousins of his who furnished him information and nurtured his love of genealogy when he was a teenager. There has been no greater step forward in the Bland Family History project. But true to the nature

of genealogy, Stephen also recognizes his indebtedness:

So much of what I know began with visits to Harrells N.C. with my great aunt Iris Bland Burch who truly was a fountain of information. She had gone back and forth between NC and GA all her life, her father being born there in 1876. She wanted to see that this history was not forgotten and passed that interest on to me. She was a remarkable lady and dearly loved by all that knew her. Perhaps this history could be dedicated to her memory - she did so much . . . to make what you see in the box a reality.

This volume then, is dedicated to Iris Bland Burch. Thank you Stephen and thanks to Graham, Willie and all the other cousins who encouraged Stephen for these many years. I think that William and Rachel and James, Esther and Jemima and their children and

grandchildren must all be smiling.

Finally, I offer my apologies to others who sent me information about their family lines, especially those who descend from Peyton Bland (1780-1815) and Elizabeth Smith (1794-1856) of the Edgefield County South Carolina Family. I gathered a lot information about this family in conjunction with the 1996 Bland Reunion, (see below) and will cover it in Volume 15.

1996 and 1997 Reunions

In the lapse of time since Volume 13 of "Among Cousins" was published, we have had two National Reunions. The Twelfth National Reunion took place in Orange Texas on August 9-11, 1996 and was sponsored by Cousins Johnson and Joann Bland Gabriel, as well as Henry Bland Jr., Patsy Bland Viator, and Mary Jane Bland Johnson. Various tabulations showed an attendance of approximately 200-225, which would make this Reunion among the largest we have had and certainly one of the most fun, best and best organized. During the three day Reunion, I spoke to the assembly about the larger history of the Bland Family and how our ancestors traced down in time to Peyton Bland (1780-1815) his wife Elizabeth Smith (1794-1856) and their three children. Derry Dunn, a local family historian, traced the family's line forward in time to the present day.

It was our good fortune that a local historical magazine, <u>Las Sabinas</u> gave over an entire volume ² to the Reunion, complete with transcripts, proclamations etc, attendance and photographs. This product was far superior to my previous efforts at Reunion Specials

and so I did not publish one for the 1996 Reunion.

The Thirteenth National Reunion was held at Shelbyville Indiana on August 15-17, 1997, sponsored by David and Lois Taylor of Shelbyville, as well as Jim and Kay McKinney of Shelbyville and Jim's sister Jannis McKinney Peterdy of Chesterfield Missouri, a very warm and cozy meeting attended by about 80-100 souls from all over the country, including many new faces and some I hadn't seen in years. In my talk, I tried to learn lessons from the past and keep it short, regaling the audience about the line of Blands that descends from Moses Bland (1718-1800) and his wife Jane Wiggonton, who settled throughout the midwest. One of these prairie settlers was Mariah Bland, whom some believe was a serial killer who disposed of at least four husbands. That was not half as interesting, however, as Lois Taylor's bus ride through the local area, which established new ground for speed and curves, and left us all, how best to say it? Breathless!! Far Out Man!!

The 1998 National Reunion The 1997 Reunion was the third Indiana Reunion. The Fourteenth National Bland Reunion will be at Mississippi, Lake Tiak-Okhata, near Louisville (Mississippi), August 14-16, 1998, and will honor the descendants of Joseph Bland (C1754-1799) of Duplin County North Carolina, brother of William Bland (1748-1816), whose family has been reappraised in this issue. The Reunion Sponsors are John and Sharon Black, 898 East Road, Starkville Mississippi, 39759. Their phone is 601-324-5377. A notice of the Reunion is enclosed. John and Sharon represent a younger generation of Bland descendants whom we need to encourage. It should be the goal of all those who attend the reunion, and I

hope to see all of you there, to bring at least one cousin with you, including someone from the younger generation.

Famous Blands on Postage Stamps??? In April 1996, I wrote to The US Philatelic Fulfillment Center, proposing that Richard Bland the Patriot (1710-1776) and Richard Parks Bland (1835-1899) be honored on a stamp (actually one for each). I sent a brief biography of each man. I received a reply May 31, 1996, advising me to be calm that the Philatelic Society had everything in hand and I shouldn't call, they would contact me, etc. How many times have you heard that line? I haven't heard a word since.

It may be that this request went on a back burner. The Philatelic Center's policy is, if the candidate is chosen, to issue commemorative stamps in conjunction with significant anniversaries of their birth. Richard the Patriot will be 300 in 2010 and Silver Dick will be 200 in 2035. I have a hunch that this is a long term project, perhaps for the next generation.

Frances Faries Bland (1922-1996) My mother, Frances Faries Bland died at age 73 on June 17, 1996. According to my Aunt Eunice, she died peacefully. I am grateful for, God knows, she did not have an easy life. Mom was born in 1922, a child of the Great Depression, from which many of her life's lessons were learned. During a visit home in 1979, I allowed my father and mother to record their stories on tape for me, for posterity. My father knew how to put on a good front, embroider just a bit.

My mother lacked these skills and her story was brutally frank and left me feeling shaken and sad at the misery her life brought her. Frances Faries was born on December 29, 1922 in West Cramerton, a tiny burg in Gaston County North Carolina, which was also a major part of my own life. Her parents were Lewis A. Farris (she spelled her name Faries) and Pearl Brazwell, hard working souls whose lives were sacrificed in the local textile mills. Truth be known, Grandpa Lewis was much more positively influential in my life than my Bland grandfather. But Lewis and my mother suffered a severe emotional blow in 1937 when my grandmother Pearl died. Lewis quickly remarried to an educated woman from Alabama, whose arrival was upsetting to my mother in a way she never resolved until late in her life, if even then. As oldest sister Mom became a mom for her younger siblings and then had to give way to her father's new wife. Mom's out was her own marriage at age 16 to Bruce Steven Bland (1922-1984) whom she had met in 1938. 3 I have a photograph of my mother taken the day she met my Dad, which she remembered because of the new dress her father purchased for her. Mom and Dad were married June 30, 1939 and I was born in July 7, 1940.

My Dad became a factory worker, but he had wanderlust in his heart and joined the US Army Air Corps shortly after Pearl Harbor.

Mom and Dad went separate ways during the war years, then reconciled for another four years, but were divorced in 1952. It can be truly said that no two people were less alike than my father and mother, Shortly after, my father remarried. For a few years after men came and went, some good, kind and gentle, (I remember one such gentleman named Woody, who was a good friend to me and a gentle man with my mother) but none stayed for the long term. Mom never remarried and she grieved because in her own view, life was wearing away and she believed she was no longer beautiful, as she once was. There was always in these years, the 50s, a sense of loneliness and frustration in Mom that I could never assuage. Mom never left West Cramerton until she was forced into a nursing home in 1991. Her life was defined by the boundaries of that little postage stamp on the globe.

As her marriage began to crumble, so did my mother's sanity and she spent several months in a mental institution in 1950, and was recommitted in 1952 and again in the late Fifties and early Sixties. There is, of course, the undiscoverable question of what "insanity" was in 1950. Years later, in 1979, Mom permitted me to investigate this question. A doctor at the Broughton State somewhat she had been confined, explained where Hospital, uncomfortably that her diagnosis of the 1950s would be treated as a problematic but mild disorder in present day. But this knowledge was years too late for Mom. When I returned from the Air Force in 1963, Mom had relapsed and was institutionalized again. She was, as they say, "calmed" by electric shock treatments. Permanently disabled, Mom survived by medication for the rest of her life.

Excepting a brief time in 1952-1954, when I lived at a boarding school, with my aunt in Texas and with my father, Mom and I were together between 1950-1958. Mom worked as a drapery sales lady and kept her demons under control. Although those years were not easy, I have fond memories of Mom then. She took good care of me, always kept me clean, well dressed and well fed. She gave me as much love as a son could want. She helped me grow up and get out on

my own. What more could I ask of her?

Mom's mental illnesses left her unable, later in life, to truly appreciate me, Mary Jane or Christina and Tom. She could never focus coherently on any subject for more than a few moments. It is sad for her, and sad for my children as well. Mom missed out on two super grand children, whose maternal grand parents died before they were born. Christina and Tom were small children when my father died, so they never really knew a grand parent's love. In Mom's last years, she sent me a video tape of old home movies that one of our relatives had strung together. On one of them, it is 1946, and there is a family reunion at my great grand parents home. There we are. I pull a wagon through the gate. My Dad, drop dead handsome as always, saunters in. And there is my Mom, young, tall, dark haired, rangy and beautiful. I wish you could see her. She turns her head briefly to the camera and begins to smile, then flits away. The photo on the next page was made at about that same time, forever young, the way Mom wanted to be remembered.

Virginia Viril Bland Long (1914-1996) My Aunt Virginia died on November 9, 1996, apparently peacefully. Aunt Virginia was born June 3, 1914, the seventh of a large family of ten children by my Grand Parents Thomas Bunyan Bland (1876-1955) and Margaret Kirby (1883-1958). She was called "Jenny Wren" in her childhood and at the behest of my Grandfather, who was not enlightened about the value of education, started work in the local cotton mill at age fourteen. Influenced however, by her older sister Grace Bland (1909-1981) and her grandmother Martha Greene Bland (1849-1935), Aunt Virginia graduated from high school in 1934. She again went to work in the Cotton Mills but secured a scholarship at Fruitland College, and then moved away to Baltimore Maryland where she stayed with her aunt Hester (1884-1983) where she completed a Nurses Training Program at Maryland General Hospital. She declined a scholarship to the University of Pennsylvania to marry Maurice R. Long. From 1945, until late in their lives, Maurice "Slim" and Virginia lived at aa home they built near her parents near Cramerton North Carolina. In the 1970s they moved to Florida, where Slim died in 1984.

Virginia lived in a little town near Deland Florida where the

Ninth National Bland Reunion was held. She attended many of the early Reunions in company with Keith and Edith Lanning and seemed to lead a happy retirement. I last saw her at the Ninth Reunion. Virginia and Slim were always very kind and good to me and for that I remember them both with fondness. The photo of Virginia was taken at the time of her parent's fiftieth anniversary, when Virginia was thirty four.



Transitions: Cousin Sherrill Hoefer from Craig Colorado, informed me that her daughter Darcy Corrine Pell had given birth to a grand child, William James Pell, on May 28, 1996. I was invited to attend Cousin Leota Bland' Ruder's 85th birthday party on February 16, 1997. I last saw Leota at the 1995 National Reunion in Rogers Arkansas. I couldn't attend her 85th, and realize that now her 86th has passed, but wish her a double happy birthday. Cousin Virgil Bland of Phoenix Arizona, who has become a faithful attender at the Bland Reunions, married Jeannie Targaczewski on November 22, 1996, In Volume 13, I announced the passing of Earl Brown, husband of Cousin Lenore Bland Brown of Paris Texas. It is my pleasure to announce that on May 3, 1997, Lenore was remarried, to an old friend Albert Chanslor Nichol. They now live in Paris Texas. Cousins Bob Bland and his wife Ethel Abbott Bland of Deland Florida, sponsors at the 1993 National Reunion, celebrated their Fiftieth Wedding Anniversary on June congratulations to all.

Sadly, just a week after the National Bland Reunion in Orange County Texas, one of that branches most devoted members passed away. Ben Bland died suddenly on August 21, 1996. Ben was a very likeable and loquacious fellow who took me under his arm and showed likeable and loquacious fellow who took me under his arm and showed me all the sights while I was at the 1996 Reunion. He first attended the 1991 Reunion In Indiana with his wife. Ben was a teacher. At the 1996 Reunion I was lucky enough to meet his wife and daughter Alice Bland Napier, who promises to carry on Ben's passionate love for genealogy, and to pose with them for the

Cousin Joyce Bland McCool notified me that her father died April 17, 1997. I learned that Lineous Preston Bland III died after a long illness at age 70, on May 19, 1997. Lineous was the son of Lineous Preston Bland (1901-1986) who was instrumental in defining much of our known history of the King and Queen County Virginia branch of the Blands.

Jim McKinney of St. Paul Indiana, whom many may know as a regular attender of the Bland Reunions, an Executive Editor of the Shelbyville Indiana News, wrote an article called "This Cancer Story is Different; Its Mine." On May 10, 1998, Jim lost his fight with cancer. Six days later, May 16, 1998, Mary Bland Day of North Vernon Indiana passed away. Mary was a dyed in the wool Bland and in her illness of recent years, attended the Reunions that were close to her. I have learned that she loved horses and that she was taken to her burial site in a horse drawn carriage. Both she and Jim will be missed.

JAMES BLAND (1661-1709)

Any discussion of the major Bland families in North America would begin with Theodorick Bland (1629-1671), founding immigrant of the James River Family, and his Northern Virginia Bland "cousin" James Bland (C1661-1709). 4 By this time, most of those who do Bland research have laid aside the thought that James was a descendant from the James River Bland Family and have accepted that he was a fourth generation Bland, who came from Penrith Township, Saint Andrews Parish, Cumberland County England (See TABLE I Below, P. 13). For those like me in my earlier years, who still look for a common origin for all us Blands, take comfort in the fact that Penrith lies in modern day Cumbria, just north of Sedberg and Orton, seat of the James River Family. Before the year 1538, however, when King Henry VIII took a census of all his subjects, in order that he might better tax them, information is sketchy and anecdotal and I have found nothing reliable to link the two families together.

Rather James descends from his great grandfather James Bland, who married Alice or Ellis Pattison or Patterson in Penrith, on June 4, 1599. That would suggest that the earliest ancestor in this line that we know of was born no later than about 1578, during the reign of Queen Elizabeth I. The northern England in which James and Alice (as I prefer to know her) embarked on their marriage was

James made a will that was probated on March 9, 1708. under the "old style" Julian Calendar, which began the new year on March 25. The British didn't adopt the Gregorian Calendar that begins January 1 until 1752. In our own reckoning his will was probated in 1709. He was then 47 when he died. James will is recorded in Will Book 2, page 460, Stanford County Virginia. Relevant previous discussions about James are found in VU, pp. 191-266. bitter, hard scrabble. The area was impoverished, rife with disease and starvation. Lest Penrith be mistaken for a thriving city, note that in 1664, just a few years after our immigrant ancestor was born, its census counted 378 homes. The primary occupation was sheep farming. When James and Alice began their marriage also, England was well into the era of the Renaissance and the massive changes that were being wrought throughout Europe by the Protestant Revolution. It was the time of the great enclosures, in which old landed wealth that competed with the power of the crown was giving way to capitalistic enterprise and acquisition. Poor farmers like James and Alice, who may have belonged to an old manorial order or at least have known of it in memory, would stay put, lacking the imagination and perhaps, resources, to do more. But not long after they were married, Englishmen first set foot in that dreadful wasteland called Virginia, named for the "virginal" Queen Elizabeth. 5 Not too many generations would pass before young people would be leaving Cumberland and striking out to make their fortune in big cities like London, or in the new world. Our ancestor was one of those.

The only known child of James Bland and Alice Patterson was James Bland, (C1600-1652), who married Susan Cook (C1600-1653) in Penrith on December 16, 1620. James and Susan had eight children in the Penrith Registry, but only two lived to adulthood.

One son who lived to adulthood was named John (1639-), who married twice and by his second wife Julia ____ had at least five children, including a son named Thomas, for whom a plausible though unproven argument may be made that he was one of the original settlers in what became King and Queen County, Virginia. 6

The other son who lived to adulthood was George (C1636-died after 1675) who married Grace _____ about 1658. Among six children of George and Grace was a son named James, who was born October 31, 1661 in Penrith.

Meaning the old lady never married. Anyone looking for the bottom line on good Queen Bess may consult Carrolly Erickson's Elizabeth. In my opinion, she was one of the greatest rulers England has had, but discussions of her virginity are greeted with gales of laughter. Astute students of the Bland family know that Queen Elizabeth's "skinner" from 1560-1594 was Adam Bland, founder of the James River family, whose son Peter took over upon his death. See VU, pp. 8-11 and 23-33. As is discussed in the first few chapters of VU, and extensively in AC 8-2, Peter went mad and the unseemly family fight for his wealth, for by about 1615, Peter was a very wealthy man, may have given the rising wealth of Peter's younger brother John, and especially his sons, the resources he needs to lay down stakes in Virginia.

James appears to have been one of those young men who left Cumberland County for a better life elsewhere, because after his birth, all traces of him disappear. A James turns up in St. Mary's County Maryland as witness to probation of a will on February 14, 1684. On March 17, 1685, another entry is found in the Lord Mayor of London's Waiting Book showing a young man named James Bland, aged 22, a "glazier and plummer," by trade, shipping out to fulfill an indenture in East Jersey province of the foundling British colonies in North America. 7 Could these two be the same man and are they in turn the same man as the one who began to turn up in Stanford County Virginia records as early as 1687? Most certainly the witness to the deed in St. Mary's county was the same man, for James spent a lot of his life between 1687-1701 shuttling back and forth between St. Mary's Maryland and Stanford Virginia. Though we have subsequently shown that the James Bland who was born in Penrith disappeared from the county records, s and that the ages fit well with the man recorded in the Lord Mayors records in 1685, those entries were made <u>after</u> James Bland witnessed the probate settlement in Maryland in 1684. This is problematic, for poor immigrants tend not to return to the country of their origin, and even less to remigrate. But I tend to accept them as the same person, because the dates are very close together. Nothing is proven, but both sources appear in secondary works and I have never been able to get the actual records. One researcher pointed out to me that officials were never too precise and especially in a purely commercial entry like to Mayor's Waiting Books, the entry might have been recorded on a date long after James actually shipped out. It would be wonderful if someone who is travelling to London could actually find the time to battle through the fierce bureaucracy

I discussed the possibility that James Bland descended from the Virginia Family of Adam Bland, through a great grandson Thomas Bland (C1634-1700) in VU, pp. 228-249, but ultimately abandoned the idea. Throughout the remainder of this I will make repeated reference to the McLeod File, representing sources found in a huge box supplied by Stephen McLeod of Talahassee Florida, (see above, pp. 2-3) I was surprised to find in the McLeod file, a letter to Stephen McLeod from Helen L. Wikoff, March 10, 1982, which also listed Thomas as James' father. I don't recall communicating with Mrs. Wikoff but this was about the time my book came out, and it leaves me wondering whether we independently came to the same conclusion back then. letter from Ruth Walker to Graham Bland, December 18, 1970, Another includes a map, C1750, of Palatinate Maryland, which reveals the close geographic proximity of Stanford County Virginia and St. Marys County Maryland, "just a row boat away" as Mrs. Walker put it, and also of what in the 17th century would have been East

that guards London records, and see what could be found, or if even the LDS records could be searched for any confirming evidence. In my own mind, I feel comfortable, until proven wrong, that these are the same person. With that premise, the founder of the Northern Virginia line would be James Bland, (1661-1709), who bought 600 acres in Stanford County in 1701 and lived out his life there.

In 1701 James, in a land purchase of 600 acres in Stanford County Virginia, "on the south side of Powell's Creek", is the balance of his life on these 600 acres and left them to his children and widow when he died. Upon his death, James left an estate with liquid assets of about \$68,000 in 1983 terms. 10

James appears to have been married to a second wife named Margaret _____, whom he identifies in his will. 11 The structure of his will suggests that at the time of his death, James had two adult sons, William and James, a third son John, who was about to reach his majority when the will was made in 1708, and five minor children, including a son Robert and daughters Alice, Hannah, Patience and Ellen, who were born between 1693-1708. 12

One of the elements of Bland research that is lacking is what happened to these daughters. One of my earliest and most avid associates, Mr. Leslie Dawson, descended from Ellen Bland, who married William Davis, a business associate of James eldest sons William and James. Nothing else is known of the daughters. 13

Regarding young son Robert, it appears certain that he died before reaching his majority, or at the least before marrying and having children. ¹⁴ This was another area of my early research in which I obscured rather than enlighten. The gist of Chapter XI of A Vision of Unity was that the son was born about 1708 and died in 1760. being the father of two Blands who migrated to South

Carolina. ¹⁵ Following publication of the book, the sharp and sometimes barely civil criticism I received for this boner, prompted me to reread the evidence and to publish a subsequent revision, as well as to make sure all my doors were locked at night. ¹⁶ Robert Bland, infant son of James Bland did, as amply noted in printed evidence, die without issue. James eldest son william had a son named Robert, probably about the same age as his uncle Robert, who is the man whose name appears in the Prince William and Loudon County deed books in the first half of the 18th Century, who died in Loudon County Virginia in 1760. ¹⁷

THE THREE SONS OF JAMES BLAND

James Bland, (1661-1709) had three sons who lived to adulthood and married. They were William Bland (Cl686-1744), James Bland (Cl687-1756) and John Bland (Cl688-1763).

James married Mary _____ Gwatkins and had a family that included at least two sons, Benjamin (1724-1771) and Arthur (C1725-1763). James Bland (- 1802) and Charles Bland (1765-1842) sons of Benjamin Bland and his wife Mary, migrated to Kentucky. 18

John Bland, married Patience _____ and had two children, John and Jesse. 19 One of his sons, John Bland, (C.1742 - 1807) moved to Kentucky, then evidently moved back to Virginia. It was my misfortune to confuse the two men. John's wife Rachel died in Washington County Kentucky about 1799. 20

The eldest son of James Bland, and the man from whom most living Blands and Bland descendants living today descend, was William Bland.

WILLIAM BLAND (1686-1744)

After his father's will was probated, William Bland first appears in official records in 1709/1710. The structure of James' will suggests that William would have been born no later (and

probably not much earlier) than about 1686. At various points in writing "Among Cousins" I have suggested that he was born earlier, perhaps as early as 1680, but this seems to be in error. The best evidence points to the 1686 date. 22

On the basis of available evidence, William acquired about 2,100 acres of land in Northern Virginia, mostly in the area that became Prince William County in 1730. William, his brother James and some of his neighbors also became engaged in a mining enterprise that failed several years after his death.

William married twice. Though dates of his first marriage are not known, it was about 1706. William had two sons by this first marriage, James (C1707-1767/774) and Robert (C1708-1760). The descendants of James Bland (C1707-1774), William's eldest son, are discussed below (pp.18ff). Robert (C1708-1760) married Jane _____ about 1729. They died in Loudon County Virginia, Robert in 1760, Jane about 1764. They had three sons, of whom two Edward (C1730-1797/1800) and Robert (C1732-1787) moved to South Carolina and raised families. 23

William married for a second time in Stafford County Virginia, to Catherine Key (Cl694-) on February 16, 1716/1717. 24 By Catherine, William was the father of Moses Bland (Cl718-1800) who moved to Randolph County North Carolina about 1770 and became a distinctive founder of a major branch of the family. 25 The same is true of Thomas Bland (Cl719-1788), who died in Fauquier County Virginia, but had several of his children move into the vicinities of Harding and Nelson Counties in Kentucky as well as western Virginia. John Bland, (Cl725-1795) third son of

William Bland and Catherine Key, married Margaret Osborne about 1747. About 1776/1780 John moved his wife, children and grandchildren to that part of Jefferson County Kentucky that would become Nelson County in 1785, where they set down extensive roots. 26 Through these five sons, William Bland (C1686-1744) has become the principal ancestral grandfather of Blands and their descendants living today. Of first interest to us is his eldest son, James Bland (C1707-1767/1774).

JAMES BLAND (1707-1767/1774)

James was born in Stafford County Virginia about 1707 and was the eldest son of William Bland (1686-1744). He is sixth generation in his family line. Milton Wilson, in his earlier study of the family, concluded that James migrated to New Hanover County North Carolina between 1757-1760. There was a local rebellion in Stafford County in 1732, in which James participate, and in 1752, the mining business James and Moses Bland inherited from their father went bad. 27 There is a legal transaction in Prince William County in 1754, which involves James. On the other hand, James acquired 200 acres on Black River on October 7, 1747. Either of these transactions could have been made in absentia, so it would seem prudent to give James a wide berth for his move to North Carolina, say 1747-1760. Certainly James was in New Hanover County North Carolina by that time, for in 1761, he returned to Prince William County Virginia to divest himself of his lands there. 28 James settled in the northern sector of New Hanover County. When James died, he was in possession of 1,800 acres in North Carolina and 300 in Virginia.

In his will, which was made out in New Hanover County North Carolina September 11, 1766, James distributed property to a wife Mary and seven children, including sons William and James Buchanan Bland and daughters Elizabeth, Catherine, Sarah, Ann and Lettice. 29

with James Bland (Cl687-1756), who was our James' uncle. Cousin Edith Lanning sent me some material indicating that a "Buck" Bland was found buried in Fauquier County, AC 3-1, p. 15. Over the years there have been suggestions that James' daughter Lettice, was the wife of Osborne Bland (Cl748-1820), eldest son of John Bland and Margaret Osborne, AC 13, pp. 40-42 or that she married a man named King in Stafford County Virginia. Neither of these ideas has been proven.

Genealogy is a sum product of attention to particular family groups by researchers. A particular line tends to be developed, like any other historical subject, according to the number of researchers who work on the line. Thus, in the family of James Bland (1707-1774, Table IV above, p. 19), the greatest amount of information is known about the eldest son of James and Mary Bland, William Bland. Very little is known about any of the other children.

WILLIAM BLAND (C1726-1775)

William is seventh generation in his family line. William's birth date is estimated at about 1726, since several of his children began to appear in the Duplin County North Carolina records in the late 1760s, meaning they were themselves born in the late 1740s. ³⁰ Thus William, as the eldest child, would have been born about 1726 in order to reach his majority, marry and have his eldest child, reckoned to be William Bland (C1748-1826). ³¹

William appears to have married about 1747, probably while the family was still in Prince William County Virginia. No one has ever determined the name of his wife, who must have already been dead in 1775 when William made out his will. What remained in the will was disposition of his estate to his children, noted in this order: William; Thomas; Charles; Mary Parker; James; John; Joseph. ³²

Four of William Bland's children have been well researched and are as follows:

- 1. <u>William Bland</u> (C1748-1816). William's family, primarily known through two sons William and James, is discussed in <u>Vision of Unity</u>, pp. 293-320.
- 2. <u>James Bland</u> (C1749-1799) James and his Descendants are discussed in <u>Vision of Unity</u>, pp. 320-342. James and his brother John settled in Chatham County North Carolina. James descendants moved away, primarily to Greene County Indiana, while John's

descendants have tended to the present day to remain nearby (See Par. 4, below) and were sponsors of the 1988 National Bland Reunion. My late and much missed cousin Al Hunter supplied me with Revolutionary service vouchers in Wilmington N.C. District for James, Joseph and John, dated between 1781-1783, confirming eligibility for DAR and SAR membership for any who descend from these lines. 33

- 3. <u>Joseph Bland</u> (C1754-1800). Joseph was noted in early issues of "Among Cousins". His descendants migrated to Alabama and Mississippi and the line has been summarized in "Among Cousins" Volumes 3-1 and 8-1. 34
- 4. <u>John Bland</u> (C1758-1827) John and his family are discussed in <u>Vision of Unity</u> pp. 284-293. 35
- 5. Charles Bland Very little is known about Charles Bland. A record has been found showing that he married Rachel Alderman and on April 19, 1791, a court proceeding named Mary Bland as his widow, with a brother William (l above) named to divide Charles' estate equitably between his widow and children. This indicates the obvious, that Charles was dead by April 1791 and that he had minor children by a second wife, adding substance to his status as a minor when his father died in 1775. 36

The descendants of James Bland are noted inter alia in the early copies of "Among Cousins" and were summarized in AC 11-1, pp. 10-32. Some supplemental information is supplied in AC 11-2, pp. 4-8 and 12-2, pp. 32-36

of Bulloch County Georgia, (1966), p. 25, hereafter identified in notes as Register, makes an interesting observation that requires further research. Citing as her source William Alderman Parker's The Alderman's in America (1957) p. 42., Register delineates the family of Daniel Alderman and Abigail Harris, and finds that one of their children was Rachel Alderman, born C 1744. In our analyses of the sons of William Bland (1726-1775) we have followed the sequence of names on William's will, and concluded that Charles was a minor when his father died in 1775. We also know from the above that Charles had died by 1791. Inasmuch as men were generally at least a few years older than their wives (exceptions always being possible), this would seem to raise very interesting and intriguing

questions about this line: If Charles were older than his wife, born in 1744, or even as old, he would easily be the eldest of William Bland's children, and this would necessarily imply that his father was born before 1726, which would imply also that his grandfather James Bland was born earlier than 1707, which would then of course raise questions about the accuracy of our assumptions that his great grandfather William Bland was born as late as 1686, which rubs up against some pretty hard documentary evidence regarding James Bland (1661-1709) etc. This is a very interesting project awaiting someone with time, patience and resources to pursue it, suggesting a need to research New Jersey, Virginia, Maryland, North Carolina and perhaps English records. The results of a thorough search would be of immense value to the Bland family.

- 6. Thomas Bland Nothing further is known of Thomas Bland.
- 7. Mary Bland m. Parker, was living in Sampson County North Carolina in 1800. 37

WILLIAM BLAND (1748-1816)

William was probably born in Virginia and moved to Duplin County North Carolina with his parents and grandparents as a child. A critical deed, dated April 2, 1816, suggests the time of William's death, and in referring to a "patent granted to me on December 16, 1769," suggests that William was born no later than 1748. It is probable that William married Rachel Powell about 1769. 38 William also was a soldier in the American Revolution. See the discussion with the family of William's grandson William (C1794-1873) below, pp. 29-31, for speculation that a major upheaval in the families fortunes, including the elder William's death and his grandson's migration from North Carolina, might have resulted from the world wide damage of a volcano that year.

Three children have been traced to William Bland and Rachel Powell. A daughter, Elizabeth Bland may have married Isaac Milton Newton in Duplin County NC, January 19, 1808. 39

WILLIAM BLAND (1771-1854)

William Bland (February 23, 1771 - 1854) was the subject of study of Milton Wilson. He married Mary C. Parker about 1793 and had six children by her. 40 Their six children, in approximate order of birth are as follows:

- 1. Rachel Bland, who married (1) Joshua Lee and (2) William Powell.
- 2. <u>Lucretia Bland</u> married William Newton on March 1, 1817. They moved to Tennessee.
- 3. <u>James Bland</u> (April 27, 1798 December 15, 1862). James lived in Duplin County North Carolina and married Mary C. Powell (C1796/1798) Their children included: 41
- A. Isaac Thomas Bland (C1822/1826). Isaac served in the CSA, as a Private in Company H, 40th North Carolina Regiment. 42 He married Mary J. Register 43 (1837-) and they had six known

In a letter to "Mr. Bland" in McLeod File, January 9, 1984, Alfreda Bland Parker, Wilmington North Carolina, also the source of Robert Bland, states that she is the daughter of James Henry Bland and that he was the son of George Washington Bland "(b.1840s d.before 1900)" and that George was a farmer on "Bull Whip" (Perhaps Bull Tail) Creek. Though Mary Alfreda Parker's information is vital to establishing the main features of this line, it appears that she meant her grandfather was John Washington Bland, son of George Tate Bland. This would also explain the appearance in these records of a George Washington Bland. Robert L. Bland to Stephen McLeod February 21, 1982, McLeod File, calls him George Tate Bland and adds substantial

Ezra Thomas Bland was living with his uncle Isaac Thomas Bland when the 1880 census was taken. Robert L. Bland declares him firmly the son of George Tate Bland and Emmeline Rackley.

I reach this conclusion on the basis of two death certificates in Sampson County North Carolina, for Kate Colwell Bland, December 31, 1959, and Fannie Ezell Bland June 21, 1965. McLeod File.

Information in McLeod File, which is somewhat confusing, indicates two other wives for Lucian Bland: Kezzie V. West, whom he married October 21, 1890 and Lizzie Alford, whom he married February 22, 1900.

JAMES BLAND (1772-1818)

The son of William Bland (1748-1816) that seems to have attracted the most concentrated attention more recently is James Bland, (C1772 - September 12, 1818). ⁵³ The reader will recall that in his 1775 will, James' grandfather William left him two cows, a calf and three yearlings, as well as a riding horse, saddle and bridle, some furniture and twenty pounds of "proclamation money," suggesting James got a good start by having his grandpa as a fan, if no one else. ⁵⁴ As a result, James

The remainder of this Newsletter updates material first introduced in VU, pp. 296-320. Delineation of this line which follows depends heavily upon notations from the McLeod File. Robert Bland has provided much of the refinement in what follows. He appropriately noted my error in fixing James' dates at 1770, yet calling him the second eldest after William, born 1771. James' father William Bland (1748-1816) at the time of <u>his</u> death showered gifts on James son Daniel White Bland (1796-1871) on Daniel's wedding day. One wonder's if this may have been because William's name sake, William Bland (C1794-1873) had already migrated from the North Carolina home to Georgia. James property was distributed in New Hanover County, North Carolina, May 21, 1825. Also, the Dower of Esther Bland was established May 19, 1825.

died a well off if not wealthy man, claiming 1,156 acres in Duplin County North Carolina. 55

James lived in Duplin County North Carolina. ⁵⁶ He married twice. First, he married Jemima Alderman (October 4, 1773 - 1800) about 1793. Jemima was the daughter of Daniel Alderman and Sarah Newton. ⁵⁷ James and Jemima had a family of three or possibly four children (see below page 62, paragraph 4, re new information about Dorcas Tabitha Bland Cl801 -). Secondly, James married Esther Newton, (1779-1854) about 1801 and by her had a family of ten children. Thus, by his two wives, James was father of thirteen children, eight sons and five daughters. By Jemima Alderman, James children were: ⁵⁸

Duplin was formed from New Hanover County in 1749. Also noteworthy is the formation of Sampson County in 1784 from Duplin/New Hanover and Pender County from New Hanover in 1875, Wilmington North Carolina, in New Hanover County, was first "New Liverpool", then "Newton" and lastly "Wilmington", named for Spencer Compton, the Earl of Wilmington. William Graham Bland to Stephen McLeod, May 1, 1982, McLeod File.

This branch of Blands, which might be called the Bulloch County Georgia Blands, intermarried extensively with the Newton and Alderman family and because of this, they were a prominent part of William Alderman Parker's book. Parker's work, as well as the McLeod File, information supplied by William Graham Bland, of Jacksonville, Florida, and other members of this family, enable a rather extended sketch of the family's growth and direction.

Birth dates for James Bland's children by his two wives are documented in a fragment that appears in McLeod File, written by William Graham Bland. As long time subscribers are aware, I have generally followed the practice of not tracing forward in time female lines of descent, for the obvious reason that to do so would increase the size of the already accumulated corpus exponentially. On occasion, however, it seems meritorious to give a little on that premise. In this case, I will detail for one generation, the children of the daughters of James Bland by his two wives.

1. William Bland (1794 - February, 1873). 59 William Bland was born in Duplin County North Carolina, though he lived his married life and died in Bulloch County Georgia. About 1814, William married Susannah Alderman, (March 14, 1795 - 1880) daughter of David Alderman, a Revolutionary War Soldier, and Jemima Hall. Susanah was born in Duplin County North Carolina. About 1816, seemingly a momentous year for this family, William and Susannah moved to Bulloch County Georgia, her parents following soon after. 60 This move to Georgia may have been precipitated by the effects of what today we would call "nuclear winter" from the fallout of a huge volcanic explosion in Indonesia, whose debris spread around the world and caused a lowering of temperatures even in North America. Their grand son Michael recalled "they came in January of the year of the September Storm." 61 Such a natural disaster would have been seen as having religious as well as physical implications. In Georgia, William and Susannah were members of and were buried at the Old Bland Cemetery located on the road between the Bethlehem and Upper Lott's Creek Church which replaced Parrish's Meeting House in 1841. 62 Though William seems not to have shared in his father's estate, (see discussion of Daniel White Bland, 1796-1871, below), he died with nearly 1,000 acres in Bulloch County. William Bland and Susannah Alderman were parents of a large family of eleven children:

William's birth date as 1794, which would make him the oldest son. Register quotes Alderman, pp. 166-167, 229, 232, 400-402. The 1850 and 1860 census list Williams age as 55 and 65, meaning he could have been born in 1794. The traditional date of birth given for William appears to be too late, for one must remember that he moved with a wife to Bulloch County Georgia about 1814/1815. If born in 1797, he would have married while still a minor. William's will was made July 12, 1872, Bulloch County Georgia Will Book, 13-A, pp. 336-338 Register, p. 41.

Moseley. David and Jemima Hall Alderman, Susannah Alderman's parents, are buried at Brannen Cemetery on Westside Road, west of Statesboro Georgia.

Willie Lee Moseley to Charles L. Bland, May 7, 1998. Hereafter called Moseley. Mrs. Moseley attached Dorothy Brannen, Life in Old Bulloch: The Story of A Wiregrass County in Georgia, (Gainesville Georgia: 1987) p. 29, which explained the origins of Upper Lotts Creek Church.

- A. <u>Jemima Bland</u>, (September 17, 1815 January 31, 1890). Jemima was born in North Carolina. She was an invalid who never married. Jemima is buried in the Old Bland Cemetery.
- B. James Bland (July 24, 1817 April 28, 1893).

 James was born in Georgia, so the variants in birthplace between him and his sister Jemima fairly well define the move to Georgia. James married Malberry Smith, (July 7, 1824 May 13, 1904) on November 30, 1842. James and Malberry Smith moved to Hamilton County, Florida and had a family of twelve children:
 - (1) Daniel Bland, (November 30, 1842 March 17,1845).
 - (2) Susannah Bland (April 7, 1843 April 3,1850).
 - (3) Elbert Bland (March 18, 1847 1933) married Elizabeth Ratcliff.

Bland (1816-1880), James brother buried near a "Niel" Bland (1817 -) who may be James. There is also Jincey Bland (September 1, 1880 - February 8, 1906) Newton Bland (1885 -) and Annie Bland, whom I have not be able to match. Perhaps they were children or grandchildren of James (1817-1893), who were not articulated. "The Blands of Bulloch County Georgia" McLeod File.

- (11) James David Bland, (March 23, 1866) married Lillian Harring.
- (12) Ezekiel Bland, (September 26, 1868) married Eveor Prather.
- C. <u>Daniel Bland</u> (1819 January 10, 1880). Daniel was born and died in Bulloch County Georgia. On September 19, 1839, ⁶⁵ Daniel married Jincy "Jency" Parrish, (September 11. 1821 February 13, 1905), a cousin of Jane Parrish, who married Daniel's brother Timothy (see E Below). Daniel and Jincey were married September 19, 1839. Daniel and Jincy are buried at the Lower Lott Creek Cemetery in Bulloch County. They had ten children:
 - (1) William Bland (June 30, 1842 July 6, 1918) William served with the CSA, 61st Georgia Regiment. He married Nicie Riggs (February 20, 1847 February 17, 1933) on August 24, 1865. William and Nicie are buried at the Zora Baptist Church Cemetery in Appling County Georgia. Their children were:
 - (a) James Bland (May 31, 1866 1925) who married (1) Ada Akins on December 30, 1888 66 and (2) Lila Black.
 - (b) Roswell Bland (February 1, 1868 1940), who married Florence Tillis. They had one daughter.
 - (c) Shelton Bland (March 23, 1869 1935) who married Florence Carter.

About 1922, Michael Bland, Daniel's grandson, erected tomb stones for Daniel and Jincy, but had to estimate their birth dates at 1817. It was later discovered that Daniel's brother James was born in 1817, and a study of old records convinced Michael that Daniel was born between 1818-1820. Gail Youmans Stokes to Stephen McLeod, June 30, 1994, notes that the 1880 Mortality Schedule of Bulloch County Georgia records Daniel Bland as age 60 when he died in January 1880. McLeod File. Robert Bland, p. 34, gives the date as September 19, as does "Marriage Records of Bullock County Georgia, from about 1875 to 1895" in Georgia Genealogical Magazine, (Winter 1990) pp. 167, 170-171. Many of the marriages noted below are gleaned from this source provided by Willie Lee Moseley in her letter to me, May 7, 1998. Cf "The Bland Family of Bulloch County Georgia" McLeod File.

a result he lived on to meet Anne Rigdon (May 21, 1853 - January 26, 1944) whom he married on January 12, 1876. Michael and Anne are buried at the East Side Cemetery in Statesboro Georgia. Their children were:

- (a) Glenn Bland (May 16, 1877 November 15, 1959), who married Mattie Jones (1881-1968). They had six children.
- (b) Alonzo Oliver Bland Sr. (December 5, 1879 January 13, 1943), who married Eugenia Matthews (1885-1968). They had four children.
- (c) David Lemuel Bland (September 22, 1882-May 13, 1947) who married Nettie Edenfield (1883-1968) on December 10, 1914. They had two children.
- (d) Leeanna "Lee" Bland (April 9, 1885 March 13, 1966) who married John Allen Jones (1870-1937). They had eleven children.
- (e) Remer Bland (February 19, 1887 September 4, 1907) was an invalid who did not marry.
- (f) Charles Kelly Bland (December 19, 1890) married Bertha Mozelle Boyd (1895-1964) on December 20, 1914. They had five children.
- (g) Daniel Edgar Bland (November 28, 1894) married Catherine Amanda O'Neal, (1897-) on November 28, 1916. He is the Dan E. Bland frequently referred to in genealogical work of this family, an active antecedent of our own time.
- (h) An Un named infant son (September 2, 1897 September 13, 1897).
- (5) Malachi M. Bland (June 9, 1851 December 28, 1912) married Martha "Mattie" Mercer, (February 25, 1862 October 14, 1939) on October 9, 1878. 70 Malachai and Mattie are buried at Lanes Church Cemetery in Stilson Georgia. Their children were:
 - (a) Lester Bland (July 25, 1879 August 2, 1928), who died in New Orleans Louisiana.

Paula Sloat calls this person Mollie. Moseley cites marriage records of Bulloch County Georgia.

- (b) Lee Bland (March 29, 1884 September 1975), married Henry Levy Sikes (1880-).
- (c) Lillian Bland (February 5, 1887) married Charley C. Newmans (1880-1956).
- Mitchell Bland (February 8, 1853 October 4, 1933). Mitchell spent his early years in Bulloch County and married there to Narcissus "Sis" Johnson Tanner (March 8, 1852 - June 6, 1921) on February 7, 1883. 71 Mitchell and Narcissus moved to Appling County Georgia in the 1890s and from there to nearby Montgomery County, where they were found in the 1900 Census and back to Appling County in 1910, where they settled in the section that became Bacon County in 1914. Narcissus suffered a stroke, her third, and died in 1921. The memories of one of his grandchildren, Dorothy Bland Crowley, suggests that Mitchell was a somewhat private, introspective man who loved nature and enjoyed playing the violin for himself and his grandchildren, but did not share his wife's passion for religion. 72 He was a hunter and older people said he was born with a veil

Moseley states "Some of my information shows Mitchell Bland married Narcissis Tanner "Bulloch County Marriage Records" cited above. Information collected by Dan E. Bland show Mitchell Bland married Marsis (Sis) Johnson. (I found notes in my files in which a great grand daughter of Mitchell Bland stated her grandmother was Narcissis Johnson. Marsie or Marsis was probably a pet name for Narcissus, but I cannot explain the name Tanner." On a stickum note to her letter Willie Moseley wrote "Narciissis Johnson was probably married to a Tanner before she married Mitchell Bland." More substantial information is provided by Gail Youmans Stokes, a descendant of Mitchell, in Volumes 1-7 of her "Bland Family News", (1992-1997) and various group sheets, which I rely on in delineating Mitchell Bland's family, Gail Youmans Stokes to Charles L. Bland, June 5, 1998. Gail's Newsletters are filled with memories and anecdotes about Mitchell, Narcissus and their children. They make for rewarding reading for anyone who descends from this line, but cannot only be touched on briefly in this number.

In "Bland Family News", Vol. 2 (May 1993) p. 4, Gail Stokes records a family legend that Narcissus was haunted by the fear that her husband's first death was caused by her refusal to prepare wine and unleavened bread for the Lord's Supper. She also was troubled by the sounds of horses screaming in a barn fire while she was married to Tanner. In this sense, Mitchell the skeptic and Narcissus the believer must have made a great couple.

over his eyes, signifying a sixth sense or psychic powers. He was buried in a coffin made from cypress lumber cut and aged by himself.

Narcissus' photo reveals a woman who is slender and tall, with black hair, long, silky and flowing, according to one of her grandchildren, but always worn in a tight bun. According to Gail Stokes, Narcissus had "very dark skin" and there is a suggestion from family stories that she may have had indian blood. Mitchell and Narcissus are buried at the Patterson Cemetery in Alma Georgia.

Mitchell's father Daniel and his wife Jincy owned slaves, probably passed to them through Jincy's family. When the Civil War ended, Daniel told them they were free to leave, stay with him or work as share croppers. An older freed woman stayed on as a house servant but after Mitchell and Narcissus were married, took up with them. Narcissus confided to the black woman that she had never been able to have children with her former husband. As the story goes, the old black woman told Narcissus to hold onto her hat (or britches maybe!), "cause she just didn't know them Blands." 73 As it happened, Mitchell and Narcissus were parents of six sons, all born in Bulloch County Georgia:

- (a) Benjamin Bland (November 3, 1883 May 5, 1957). The Benjamin married Thursie Ellen Stewart (1889-1953) on February 20, 1910 in Appling County Georgia. Ben died of cancer and he and Thursie are buried together at the Steward Cemetery in Bacon County Georgia. Following the death of Ivey Harris Alderman, Ira Bland married Margaret Dixon Boyette (1883-1975) Cl909, and by her had two children:

- (d) Theodore Cyrus Bland (December 20, 1910 August 22, 1986), of Harrells, North Carolina, who married Mary Jane Waters (1921-) on November 25, 1941. 109 Theodore and Mary Jane had three children.
- (e) Emma Oleta Bland (April 23, 1913) married Richard Southerland of Wallace North Carolina on December 23, 1938. Emma and Richard had four children.
- (3) Lafayette Bland (June 18, 1859 September 23, 1943). Family historian Lillian McRee writes "It seems that La Fayette walked to Georgia with his musket slung over his shoulder." Interestingly enough, Lillian doesn't hint at the objective of such a purposeful journey. She speaks tenderly of her grandfather, remembering him as kind and gentle with girls and women, but somewhat rough with boys. She described him in his later years, "ramrod straight, full head of

white hair, sharp blue eyed man." 110 Whatever his intent, in Telfair County Georgia, he met and married Huldah Jane Wooten (November 6, 1872 - November 5, 1927) 111 on February 23, 1888 and supposedly put the musket away. Perhaps he learned in Georgia that the Yankees had been gone for more than a decade. Lafayette and Huldah were married at Wooten's Mill and they lived at Jacksonville Georgia and later at Lumber City where Lafayette had a lumber mill and a small railroad named the Old Erie Lumber Company Railroad. Later in life, Lafayette and Huldah moved to Valdosta and Georgia and in his later years, following Huldah's death, Lafayette moved to Atlanta to live with his sons. He is buried at Valdosta Georgia. Lafayette and Huldah lived substantially and seemed to prosper in their lives. Lillian McRee writes that the family tradition had it that Lafayette and his brother Dan (page 55, paragraph 4 below) dated Mattie and Huldah Wooten in the reverse of which they were married. One day they decided to swap partners and then never swapped back. Lafayette and Huldah had family of seven children:

- (a) Claude Bland, (December 6, 1888 C1978/1979) later known as John Sweet, was born at Wooten's Mill, Georgia and he died at Fort Dodge Iowa. He married (1) Mamie Hyman, by whom he had three children; (2) Cora Kline by whom he had a daughter who died in infancy and (3) Mary Ellen ____. There were no children by the last two wives.
- (b) Edwin D. "Edd" Bland, (March 2, 1891 September 11, 1894).
- (c) Lee Roy Bland, (May 25, 1893) Lee Roy married (1) Artis Smith and (2) Irene Gervin. There were no children by either of these marriages.

The Lafayette Bland, Huldah Wooten Family record is brought to life by a narrative written by Lillian McRee for her daughter Beth McRee Cannon, undated, in McLeod File.

Lillian Mcree paints a portrait of Huldah Jane Wooten as fearless, who once avoided a panther by driving straight into a church and slamming the door. Charmingly, she said her grandmother "could dream in chapters, picking up the dream each night for another exciting addition." McLeod File.

- (d) Henrietta Elizabeth Bland, (June 18, 1895 February 23, 1980). Henrietta married (actually she eloped with) Hugh Jane "Eugene" Gibson Newham (1894-1933) on July 27, 1913. Stephen McLeod writes "Henrietta was a beautiful person whom all the family loved." Lillian McRee wrote that Henrietta's parents forbade her to see Newham, a son of a horse trader, who was considered beneath their station, thus they eloped. Henrietta and Edwin Newham were separated and eventually divorced, and Newham had the misfortune of having his leg amputated after being run over by a train. 112
- (e) Rosa Lee or Rosalie Bland, (May 25, 1897 February 19, 1933), who married Otto Floyd Helm on June 5, 1915. They had two children.
- (f) Merrie Woodberry Bland, (June 28, 1899 -) who never married.
- (g) Alma Edda Bland, (November 6, 1902 January 13, 1959. She married Harry J. Craig. Alma and Harry had one child.
- (4) Daniel Tate Bland (November 2, 1860 January 24, 1959) at Harrells North Carolina. Like his older brother, he removed to Telfair County Georgia, where he lived out his life. Daniel served in the Civil War on the side of the CSA though you wouldn't find him on any of the muster rolls. As it happened, when the Yankees came to his father's house and started pilfering property, they made the serious mistake of taking little Danny's change purse. Dan "lit into the soldier for all he was worth, kicking, hitting and biting. When the commanding officer was alerted to the commotion, he ordered the soldier to 'give the little boy back his money." 113 God Damned Yankees, but that was a nice commanding officer eh? Like his brother, Lafayette (above, pp. 53-54, Paragraph 3) Dan married a Wooten

 - (c) John Wooten Bland (April 29 1894 January 26, 1969), married Ethel McDougald (1898-1976). They had three children.

Mattie always kept the year of her birth a secret.

This family is detailed in a typed but unsigned family group sheet, McLeod File.

- (b) Dan Edd Bland (August 17, 1912 January 16, 1978) who married Ruby Lee Croxton (1916) on January 20, 1943. Dan and Ruby lived at Crestview Florida, and had three children.
- (c) Jim Andrew Bland (December 26, 1914 October 12, 1919).
- (d) David Paul Bland (November 10, 1918) Married Lula Mae Scott (1921-) on November 10, 1945. David and Lula had one child.
- (6) Cornelia "Neely" Ann Bland, (December 28, 1867 December 24, 1932) married Willis Hall Wooten, (C1869-1941), a brother of Huldah and Mattie Wooten, 117 by whom she had seven children.
- (7) Ida Dorcas Bland, (July 31, 1874 September 6, 1972). According to Stephen McLeod, Ida was "a wonderful person" and was a great contributor of knowledge about this branch of the Blands. Ida created a scandal when she refused to marry the father of her only child:
- (a) Arthur Bryant Bland (February 22, 1894 July 25, 1970) Arthur was raised and educated by his mother and became a dentist. He married Eva Mae Jones (1902-1964). Arthur and Eva had three children.
- (8) James Oscar Bland Sr. (March 7, 1876 February 21, 1960). James moved to Telfair County Georgia between 1885-1890 with his grandma Margaret Blanton Bland begging "please Jim, don't leave me." But like the old song goes, Georgia was on Jim's mind and off he went. James married Lula Clements (March 21, 1878 June 18, 1944) on November 22, 1898. James was a successful businessman in Jacksonville, Telfair County Georgia, where he died. According to Stephen McLeod, "A cousin once said that he had a mortgage on practically the entire city of McRae Georgia. I think the Depression and other things eventually reversed a lot of his fortune." 118

- (c) Earl Elgin Bland, (October 21, 1902) married (1) Mary Louise Malloy (1905-1963) on June 12, 1929 and (2) Mildred Newton (1913-).
- (d) Guy Rupert Bland (July 31, 1905 November 10, 1977). Guy married Martha Olivia Boney (1912-) on April 21, 1932. There were three children in this marriage.
- (e) Azelene "Addye" Bland (October 15, 1907) married Floyd Walter Williams (1901-1956) on January 1, 1928. They had one child.
- (f) Daniel Ed Bland Sr. (June 10, 1910), Born in Telfair County Georgia, Dan attended South Georgia and Douglas Colleges. On June 10, 1937, he married Mary Alice Thomas (1915-). They had three children. 121
- (g) Charlie Walter Bland (July 14, 1915 May 3, 1934) was born in Telfair Georgia and died of a heart attack.

- (i) Mary Josephine Bland (July 21, 1919). Mary Josephine Bland was a teacher, who received her degree from the George Woman's College at Millidgeville. She married J. Frank Hatton (1917) on June 21, 1947. They had two children.
- (j) An unnamed infant, born and died 1920.
- (k) James Julian Bland (February 10, 1922 -) married Dorothy Anderson (1924) on June 10, 1942. They had five children.
- D. <u>John Bland</u> (C1823 C1862). John was killed in the Civil War. Robert Bland believes he must have served in Company H, 40th North Carolina Regiment. John never married.

E. Elizabeth "Betsy" Bland (C1824 - living in 1871) On March 10., 1853, Elizabeth married Joshua Blanton (C1830 -) and moved with him to the Florida territory. Joshua Blanton was the son of Elizabeth's aunt and uncle, Dorcas Bland Blanton and John Blanton, (See Below, page 63, paragraph 4F). Joshua was remembered as "old man Joshua Blanton". The story is told that during the Civil War, while the Yankees were marching through Harrells, (see the story of Daniel Tate Bland p. 55 above), Daniel White Bland hid all the livestock in the woods so that when the Yankees arrived, they found a far with no stock. The story is told that the Yankees dragged Joshua off alone and harassed, and then bribed him to tell them where the live stock was. This event left Joshua in disfavor and contributed to his decision to move to Florida. Elizabeth and Joshua may have settled in Madison County Florida, and they had three sons, Cason, Dan and Will. 122

There follows a ten year gap in child births, by our best calculations. A good question would be why this was?

- H. <u>Harmon Bland</u> (July 22, 1839 August 12, 1924). Harmon married twice: (1) Alvania Peterson (April 15, 1842 October 8, 1896) and (2) Sarah Sylvania Bland (1852-1937), a cousin and daughter of Timothy Bland (1818-1883) and Adaline Ward (see below, page 100, paragraph 13G). Harmon had three daughters by Alvania Peterson:
 - (1) Dollie Bland (December 21, 1873 April 6, 1946). Dollie married (1) William Wright Harvell and (2) Thomas Ashley Garriss.
 - (2) Minnie Vance Bland, (Cl873) 123 who married Jesse B. Farrow.
 - (3) Nettie Priscilla Bland, (Cl879) who married James J. Moore, a chief of police in Wilmington. 124
- I. <u>Tabitha Caroline Bland</u> (October 21, 1842 January 1, 1901) "Aunt Lina" married Allen Bryant Peterson and by him had a family of six children. 125

- 4. <u>Dorcas Tabitha Bland</u> (C1801) married John Blanton (C1794) about October 1, 1818 in Duplin County North Carolina. They had nine children, some who intermarried with their Bland cousins. 130

From McEachern Notes: The daughter of John Blanton and Dorcas Bland, Esther Blanton, was born about 1828. She married James Fryar, son of Edith Bland and John Fryar. CF Robert Bland, p. 45. A. Clarke Blanton to Charles L. Bland, April 17, 1998, gives Dorcas a middle name Tabitha, the only source I've seen for this so far. Clarke Blanton has also enlarged the number of children of Dorcas Bland and John Blanton, and I rely on his information, since he is, I believe, the first to descend directly from the line. Also, the marriage date of October 1, 1818, forces us to push the date of Dorcas' birth back as far as possible to c1801. The 1850 Census of Duplin County North Carolina finds John Blanton, age 56, married to Tabitha Blanton, age 50. Given Dorcas Tabitha's now known marriage date, this is quite realistic. It would certainly make her the eldest of James Bland's children by Esther Newton and would raise the question whether she was the daughter of Jemima Alderman, born more precisely as the census taker reported, in 1800. More information about this would be appreciated. Hereafter, A. Clarke Blanton's letter is referred to as Blanton.

- F. <u>Joshua Blanton</u> (C1828) Joshua married Elizabeth Bland (C1826) daughter of his mother's half-brother Daniel White Bland (1796-1871) and Dorcas Page, (See Above Page 59, paragraph 2E). Joshua and Elizabeth moved to Florida.
- G. <u>Tabitha Ann Blanton</u> (C1833) Tabitha married George Washington Fryar, a son of John Fryar and Edith Bland, half sister of Tabitha's mother, (see above, page 61, Paragraph 3G). Tabitha and George had six children. 131
 - H. John Thomas Blanton (C1833)
- I. Moses Newton Blanton (C1839 1930) born in North Carolina and died in Horry County South Carolina. Moses served with the First South Carolina Regiment from Horry County between August 7, 1861 and was still enlisted December 31, 1864. Moses married (1) Avy Jane Alford and (2) Helen Victoria Alford. Between these two women, Moses had ten children. 132

These are the children of Dorcas Tabitha Bland and John Blanton.

5. Anna Bland (May 2, 1802 - May 16, 1847). On April 6, 1823, Anna married her first cousin, Enoch Alderman (January 16, 1801 - September 4, 1879). They moved to Marion County Georgia between 1840-1845. This was a family that knew tragedy for two and possibly three of their sons were killed in the Civil War. They had eight children:

Information about this family is provided primarily from Mazine Winstead to Stephen McLeod, May 7 and May 30, 1989, McLeod File. After the death of Anna Bland, between 1854-1855, Enoch Alderman moved away to Leake and then Lincoln County Mississippi, where he served as a Baptist preacher. On November 27, 1850, Enoch Alderman remarried to Susan Ann Hardage (1816-1889).

- A. Amariah Alderman (July 30, 1825 August 13, 1858) married Mary Emaline Clayton on October 12, 1848. No information was found by Parker about descendants from this marriage.
- B. Esther Ann Alderman (October 24, 1827 November 24, 1898), married (1) Redmond Yates (1857) on September 17, 1846. They had four children. Second, Esther married John Wells on March 30, 1858 and by him had five children.
- C. <u>James Alderman</u> (December 9, 1828 October 25, 1862).

 134 James married Mary E. Sanders November 19, 1850 and may have moved to Mississippi after relocating to Georgia with his father.
- D. <u>John Henry Alderman</u> (September 9, 1831 August 29, 1862). John served in the CSA, with the 26th Georgia Regiment and was killed at the Second Battle of Bull Run. John married Lavinia Alderman, a cousin, on July 2, 1854. They had two children.
 - E. Charity Alderman (September 21, 1833 November 4, 1844).
- F. Margaret James Alderman (August 3, 1835 June 1902), married John Newton Heath on September 14, 1852. They had six children.
- G. <u>Stephen Alderman</u> (October 23, 1837 August 12, 1863), was killed in the Civil War. Stephen married Melvina McPhail on June 8, 1859 and by her had one child.
- H. Jemima Alderman (March 9, 1840 September 27, 1873) married Jones Brown on October 7, 1858 and they had two children. Second, Jemima married John W. Jordon on April 11, 1866 and had two children with him. The juxtaposition of the last child's birth date suggests that Jemima died from child birth.

These are the children of Anna Bland and Enoch Alderman.

6. <u>Isaac Newton Bland</u> (December 17, 1803 - August 16, 1875).

The date of death suggests that James was a Civil War Soldier.

Major changes in information about this line came from a folder marked "Isaac Newton Bland - Mary Elizabeth Alderman" in McLeod File. Though the information was random, it contained information about the families of most of their children and their allied families. Additional precision for Isaac Newton Bland's dates were provided by Karen Roberts, Deland Florida, at the 1993 Bland Reunion.

James Finley Bland and Mary Johnson had three sons. Parker indicates all three were successful businessmen in Mayesville and Sumter, South Carolina:

William also was the founder and first principal of the Mingo High School, organized about 1880 in Sampson County, North Carolina. 156 He devoted much of his life to the enhancement of the Mingo school. William married Ellen Newton, (March 31, 1858 - April 1, 1939) on January 27, 1882. They had a family of nine children:

Unlike her sister Lorena, Allie was not a big one for formal education, and Lorena remembered that it was often necessary for her to be whipped to make her go to school (I know the feeling). On the question of marriage her advice to her niece Karen Roberts was that a woman needs a man like a fish needs a bicycle (I think that's the way it goes), telling her "she could never understand why so many young women got married and had lots of children and for the rest of their life have 'some old man bossing them around.'" 161 There you go! I must say, however, that if all Bland women followed her advice, my Newsletters wouldn't be as long as they are.
- (9) Rosa or Rose Bland (September 13, 1898 March 9, 1929), never married.
- F. Mary Elizabeth Bland (October 7, 1839 January 10, 1908). Mary Elizabeth married John R. Register (November 26, 1848 February 25, 1899). Prior to marrying Mary Elizabeth, John Register married Elizabeth Rogers, daughter of Mary Bland (C1807/1808) and Reuben Rogers. (see below, page 74, paragraph 7A).
- G. <u>Lavinia Bland</u> (January 18, 1842 April 30, 1915). She married Thomas Vann on February 1, 1866. ¹⁶² Lavinia is buried on the Vann farm in Lisbon, Sampson County N.C. They had four children. ¹⁶³
- H. John Thomas Bland (October 26, 1843 May 3, 1913). Of John Thomas Bland's life, Parker learned only that he served in the CSA, Company A, 41st North Carolina Regiment. This means that the children of these two marriages were double first cousins. 168 Mary and Reuben lived in New Hanover County North Carolina and Reuben moved to Sampson County after Mary's death. About 1854, Amariah purchased a tract of land near Rose Hill, in Duplin County, North Carolina, and built a house upon it that was occupied by Blands until about 1889, and is still standing near Rose Hill, North Carolina. 171

About 1830, Amariah Bland married Mary Page, (December 16, 1810 - February 1, 1874) a sister of Dorcas Page, who married Amariah's half-brother, Daniel White Bland (See above, page 50, paragraph 2). Amariah and Mary had a large family of eleven children including: 172

A. <u>Sarah Ann Bland</u> (April 21, 1832 - December 19, 1861). On December 16, 1856, Sarah married Charles Wright Savage (1831-1916), and by him had a son and two daughters.

Amariah's family is discussed in Robert Bland, pp. 47-50. Amariah Bland is the ancestral grandfather of a key correspondent to the author, William Graham Bland of Jacksonville, Florida. Graham related an apocryphal story of two Union soldiers who were killed and buried near the Amariah Bland house during the Civil War. According to legend, Anne Eliza Young, wife of Amariah's son, George Washington Bland, was spooked by the sight of an apparition of a horse and phantom rider galloping past her house, a short distance from the Amariah Bland house, which might have been one of these Union soldiers who went South to die, reversing James Dickey's dictum for Southerners that the North is a place where southerners go to die.  John was captured at Malvern Hill Virginia on July 1, 1862, He was exchanged at Aiken's landing, James River Virginia on August 5, 1862. He returned to duty January-April 1863 but was wounded on August 21, 1864. There was no further record of John J. Bland. He married Mary Catherine Johnson (July 24, 1842 C1895) on February 26, 1863. Mary Catherine was the daughter of Allen Taylor Johnson and Jemima Bland (See above page 51, paragraph 2A). Nothing more is known about this couple. It may be that in their brief marriage, no children resulted. Mary Catherine remarried after John's death, to John E. Powell on March 22, 1866. 175
- C. George Washington Bland (March 4, 1836 April 2, 1906). George served in the CSA, Company A, 41st North Carolina Regiment. On February 14, 1875, George married Anne Eliza Young (August 25, 1850 June 19, 1927) 176 There were six children by this marriage, including:

William Graham Bland, <u>Memorandum for the Record</u> April 6, 1982, ACl-1, Attachment 5, quotes a letter from Stephen McLeod, November 18, 1981, "In my possession is the Johnson Family Bible, with a very good record of the family. John James Bland died July 12, 1864, with no issue. Mary Johnson was the daughter of Allen Taylor Johnson and Jemima Bland (Daughter of Daniel). She was a second cousin of John James Bland. She was later married to Mr. John E. Powell and had 3 children." The noted military record of John J. Bland indicates that he was wounded August 21, 1864 and thus offers an alterative date of death.

dad and I visited Theodore Cyrus Bland of Harrells and on our return, stopped at Rose Hill and visited the Bland cemetery, which I had already heard of through William Graham Bland. From out of nowhere there appeared a sprightly lady tearing across the road like Snyder's Hound (Thanks Mom. I never met Snyder and his dog but when you said this, I knew what it meant and it was always funny), coming after us like a Victorian father chasing a dust man out of his daughter's bedroom. It was this very Anna Katherine Scott Bland, who, discovering we were not grave robbers, but rather poor Bland cousins, showed us through the well and lovingly kept grave yard, of which I had heard so much. She then invited us back to her home for coffee and sweets and a nice chat before we resumed our homeward journey. It was a nice visit, and a nice day with my Dad, one of the very few left to me before he died in March 1984.

Amariah Bland inscribed upon David's tombstone (David is buried beside his parents) a passage that is simple, eloquent, and a perfect inspiration for genealogists: "...to live in the hearts we leave behind, is not to die." ¹⁸¹ David enlisted August 28, 1861, with Company "E", 30th Regiment, North Carolina Troops. David's company was called the "Duplin Turpentine Boys". Some time later David was hospitalized at Wilmington North Carolina with typhoid fever. He died at Wilmington and was "carried home by his father." ¹⁸² David was the first of Amariah and Mary's children to be buried in the family center and his grave originated what is now the Rose Hill North Carolina Cemetery.
- F. <u>Joseph Marion Bland</u> (September 12, 1842 December 1843). The death of baby Joseph was followed quickly by the death of Amariah Bland and Mary Page's seventh child:

This document notes David's death as March 9, 1862 whereas his tombstone and the Family Bible Record indicates shows the date as March 8 (William Graham Bland, Memorandum for Whom it May Concern, April 6, 1982. Both documents appear as Attachment 5 of AC 1-1.

- H. Abram Francis Bland, (December 18, 1845 August 31, 1918). During the Civil War, Abram served the CSA with I Company, 10th North Carolina Regiment. Abram is buried at the Rockfish Creek Cemetery in Wallace North Carolina. He married Harriet Dobson (December 27, 1853 August 19, 1906) on April 24, 1873. Abram Francis Bland and Harriet Dobson resided at Teachey North Carolina and had a family of seven children, including:
 - (1) Margaret Juanita Bland (March 11, 1874 June 20, 1946), who married John C. McMillan Jr. (1863-1932). They had eight children.
 - (2) Mary B. Bland (February 29, 1876 December 12, 1927) who married Henry Franklin Boney (1875-1950). They had four children.
 - (3) Coy Bland (March 10, 1877 to March 30, 1938) who married Gabrielle Robinson. They had five children.
 - (4) Louise Bland (May 24, 1883 to May 29, 1950) who married Henry D. MacMillan (1871-1954). They had four children.
 - (5) Daniel Graham Bland (January 17, 1889 1943). Daniel attended Wake Forest College for three years but was forced to leave college because of serious illness. He was a successful business man in lumber and real estate. He was a member of the Georgia House of Representatives from 1919-1936 and a member of the Georgia Senate from 1940-1942. Daniel married Willie Love Wall (1891-1944) on July 12, 1910. Their children were: 183

 - (b) Stephen Graham Bland (May 1, 1914)
 Stephen attended the University of Georgia Law
 School in 1936. Stephen served in the U.S. Army
 Air Corps in World War II. He was married to Madge

 - (c) Harriette Love Bland, (November 23, 1916) who married C. Norman Williamson.

Shuler called me in 1983 to say that he had never known who his mother was because he was adopted at about age 2, by his uncle Gaston Amariah Wilder Bland and Gaston's wife Annie Mason. Graham Bland was good enough to reveal the name of Shuler's mother.

K. <u>Gaston Amariah Wilder Bland</u>, (May 18, 1857 - 1932). "Willie," as he was called, 189 married Annie Mason. When they were married or whether they had children does not appear.

These were the children of Amariah Bland and his wife, Mary Page.

9. <u>James Thomas Bland</u> (December 30, 1810 - August 23, 1886). James Thomas lived most of his life on Long Creek or Moore's Creek, in Sampson County, North Carolina and had a reputation as a good citizen. He is buried above the upper stretch of Moore's Creek in Pender County North Carolina. 190

James Thomas Bland married two women. His first wife was Dinah Alderman, (October 20, 1813 -1850) whom he married about 1830. The interrelationships of families was such that Dinah was the niece of Jemima Alderman, James Thomas's step mother. James Thomas Bland and Dinah Alderman had a family of six children:

- A. <u>Daniel P. Bland</u> (December 6, 1831 or 1836 January 9, 1903) married Eliza Corbett (1845-1925). Daniel with his brother Hanson, was also enlisted in the CSA, Company A, 41st NC Regiment.
- B. <u>Hanson Alderman Bland</u> (May 13, 1841 December 22, 1912). Hanson married Sarah Ann Moore, (February 7, 1843 August 19, 1921) a cousin, on January 1, 1878. She is said to be buried in the Herring Graveyard, presumably in Pender or New Hanover County North Carolina. 192 Hanson with his brother Daniel,

McEachern, Op. Cit. identifies him as "William"...

As of 1983, his burial site had been overrun by nature and a tree was growing at his foot stone. Per E-Mail to Charles Bland, April 26, 1998, Robert Bland informed me that in the early 1990s, "The descendants of James Thomas Bland moved the headstone from his grave to the family plot in Burgaw, NC, where his son James Thomas and others are buried. The headstone was set up and a marker giving explicit directions to his actual grave was installed. A new headstone was erected in the woods at the site of his grave."

Robert Bland, p. 30. I have previously referred to Margaret as Hendry. According to Robert Bland, Hendry is a variant of Henry, Robert Bland, pp. 23-24. In 1983, Robert expressed doubts about Margaret's birth date. She evidently, if census records are to be believed, 41 when she married and had never married before. Robert indicates that she was not a physically strong woman and that child birth in 1853, extremely difficult in those days for a 43 year old woman, must have shortened her life.


G. John Thomas Bland Sr. (January 22, 1853 - July 24, 1928)

198 John was born near Burgaw in the section of New Hanover
County North Carolina that became Pender County in 1875. John
Thomas graduated from Wake Forest College in 1876 with a Bachelor
of Law Degree. He read for the Law under J.L. Stewart of Clinton
N.C. and was admitted to the North Carolina Bar in June 1878.
John practiced law in Burgaw, North Carolina, as an attorney for
the Atlantic Coast Railway. He was an active Democrat, serving on
the party's executive committee for Pender County and as a North
Carolina State Representative from Pender County, 1885-1887. He
was the founder of the Burgaw Baptist Church. On January 15, 1880
married Lorena Davis Williams (September 16, 1864 - September 23,
1936), 199 by whom he had a large family of eleven children:

Robert Bland, p. 32, identifies Lorena as "the fifteen year old daughter of Archibald Hendry Williams. . .", cf Robert Bland, p. 52. With this new information, I am pleased to correct the confused information that appears in AC 1-2, p. 4. Robert Bland wrote a second large work which he sent to Stephen McLeod in 1983, called The Blands of Topsail, which supplements the piece referred to in this work inter alia as Robert Bland. The second work will be referred to only as TopSail, and its pages are unnumbered. It appears to have been written before Robert Bland. Topsail discusses primarily the descendants of John Thomas Bland Jr. Robert R. Bland to Stephen McLeod, June 16, 1983 and December 16, 1983, McLeod File.

- (5) Wingate F. Bland (died at age nine months, he is buried under an undated stone).
- (6) John Thomas Bland Jr. (June 10, 1890 March 8, 1935). John was a Wilsonian Democrat, which must have been one of the most exhilarating experiences a politically conscious young man could have had at that time. God, how I envy him that experience! In San Francisco in 1920, he seconded the nomination of James Cox, who would win the nomination and ultimately lose the election while running with 38 year old Franklin Delano Roosevelt, a dynamic young man who in 1920 had powerful legs and would later have the most powerful coat tails of any President. Reaves, however, paints an ultimately pessimistic picture of this man's life:

John Thomas Bland was a young man of unusual ability, gentle, refined and a lovable nature. John was, however, exceedingly temperamental, which caused him to live in a world all his own-the land of fanciful dreams, but whose untimely death brought sorrow to many hearts.

Reaves takes his cue from a poem written by John "These Lowly Lays of Mine" in which he begins

"I live in the land of far-away, In the land of Fanciful Dream . . " 203

Robert Bland in <u>Topsail</u> writes: "It was difficult to express one's creative spirit in Burgaw. And the rejection of Wilsonian Dreams by the "return to normalcy" of the twenties, affected J.T. These problems led to heavy drinking . . . his drinking, combined with the onset of diabetes in an age when the disease was basically untreatable, led to his death. 204

John married Nancy Daniel Goode (July 21, 1888 - March 8, 1979), on July 19, 1913. Their marriage was called "rocky and productive" by Robert Bland, and John's

Two of these sons, Thomas Henry Bland and his wife Diana Jo Kramer and William Goode Bland and his wife Diane Daphne Soros, sponsored the Sixth National Bland Reunion at Prince William County Virginia, with one of the largest turnouts of any of the thirteen we've had so far. Their son Robert Russell Bland, is the compiler of Bland and Russell Lines noted throughout this work.

- 10. <u>Jemima Bland</u> (October 3, 1812 December 15, 1889). Jemima's obituary notice portrays her as a deeply devoted and religious person. Jemima must have been a wonderful cook. Her husband was almost 100 when he died and the children who escaped the Civil War lived into the 20th century and died between ages 71 and 95. On January 2, 1829, she married Benjamin Rogers (April 10, 1810 January 31, 1908), a brother of Reuben Rogers, husband of Jemima's sister Mary (see above, page 74, paragraph 7). They lived in Sampson County and had a family of 14 children:
 - A. Infant Child No dates.
- B. Margaret Ann Rogers, (August 15, 1831 January 21, 1918). Margaret never married. A photograph of Margaret Ann Rogers is displayed below.
- C. Mary Elizabeth Rogers, (October 17, 1833 July 20, 1928). Mary never married.
- D. <u>William Wells Rogers</u>, (March 5, 1836 March 6, 1864), never married and died in the Civil War. He served in the 61st North Carolina Regiment, CSA, and died in a hospital in Petersburg Virginia. William wrote his parents several letters in 1863 including one from Wilmington North Carolina in September, telling them how much he missed home and hoped that a new doctor

McLeod File indicates that marriage records for James Thomas and his last two wives are filed in the New Hanover County Court House. Lucaty Smith Moore was previously identified as, "the widow Douglas Hand."

Dates of Jemima Bland and Reuben Rogers' family is reinforced by letters from Jimmy Comer to Stephen McLeod, June 9, and July 15, 1982. Obituary of Jemima Bland Rogers, January 15, 1890. Mr. Comer also notes that most of the family are buried at the Rogers Family Burial Ground near Franklin in Sampson County. Also useful was a letter from Margaret E. in the regiment would release him to go home, since he had suffered from an aguish fever. But it wasn't to be. William's letters were articulate, sweet and sorrowful and did not contain the graphic descriptions of war that marked the letters of his brother David (G below). When they could, both William and David passed on news to neighbors of the whereabouts and well being of their sons.

- E. <u>Sarah Catherine Rogers</u> (July 9, 1837 February 6, 1926). Sarah married James William Merritt (1827 1887) on January 3, 1867. James was a Civil War Soldier. A photo of Sarah Catherine Rogers Merritt is displayed below.
- F. <u>Isaac Thomas Rogers</u> (April 9, 1839 February 22, 1915), married Elizabeth Ann Oates Ezell (1839 1914) September 5, 1865. Isaac enlisted as a private in Company D, 63rd North Carolina Regiment May 16, 1862 and served through September 1864.
- G. David Franklin Rogers (July 8, 1841 March 24, 1865). David never married and died in the Civil War of Dysentery. Historian Kenneth Davis in Don't Know Much About The Civil War, notes that dysentery on both sides was the greatest killer in the war. David wrote home on December 21, 1863, "expecting the yankeys to make a raid every day." On June 3, 1864, David wrote a touching letter to his mother and father telling them that he had been in "a grait battle today. I don't think our loss was very grait. It is said that the slaughter of the enemy great, the part of my Company are almost awl killed, wounded and taken prisoners."
- H. <u>Susan Jemima Rogers</u> (January 11, 1844 September 24, 1917). Susan married Marshall Henderson Oates November 24, 1867.
- I. <u>Tabitha Helen Rogers</u> (November 30, 1846 January 20, 1930). Tabitha never married.
- J. <u>Benjamin Howell Rogers</u> (January 5, 1848 March 11, 1927). Benjamin never married.
- K. <u>James Marshall Rogers</u> (February 5, 1850 July 14, 1938). James married (1) Dicey Ann Highsmith Robinson (C1846) sometime between June 14, 1880 and June 16, 1881 and (2) Maggie Rebecca Highsmith, May 15, 1907. James was living at home as late as 1880.
- L. Anson Edward Rogers (May 10, 1852 October 29, 1923). Anson never married. Anson fell off a roof when he was young, but his legs got caught, leaving him dangling upside down, an

experience that damaged his spinal cord, and left him with what Jimmy Comer calls "St. Vitus' Dance".

M. <u>Stephen Oliver Rogers</u> (August 18, 1854 - April 19, 1934). Stephen married Celena Clyde Highsmith (Cl858-1900) about 1880.

N. <u>Luther Rice Rogers</u> (April 1, 1857 - May 23, 1934). Luther married Catherine "Cate" Euphina Rackley (June 21, 1874 - July 14, 1955) in 1896.

These are the children of Jemima Bland and Benjamin Rogers.

- 11. <u>David Bland</u> (c1813/1814 C1840) died as a young man and never married. 210
- 12. Enoch Bland (C1815 March 21, 1871). 211 Enoch served in the CSA as a private, Company A, Third NC Cavalry, From October 1861 to June 1862. 212 Enoch is buried at the Wells Chapel Church. He married Mary Jane Lee (January 9, 1823 living in 1880) about 1837. 213 Their four children were:
- A. Lewis Frank Bland (August 13, 1848 January 17, 1919). Lewis was born in Duplin County North Carolina. He married his cousin Emma Bland, (1855-1932) grandchild of Daniel White Bland and Dorcas Page and son of James Thomas Bland and Mary Ann Simmons, (see above page 52, paragraph 2C(1)). Both Lewis and Emnma are buried at Wells Chapel Cemetery in Harrells North Carolina. They had a family of six children: 214
 - (1) Claudius Bland (January 17, 1879 July 16, 1879).
 - (2) Edgar Lee Bland (April 13, 1881 March 6, 1948) Edgar operated a store in Harrells North Carolina but never married. He is buried at Wells Chapel Cemetery.
 - (3) Mary Fannie Bland (October 16, 1885 August 13, 1923). Mary never married and died of cancer.

The fact that David died without heirs is borne out by a sale of 118 acres from various of James Bland's children to Timothy Bland, the land that previously was awarded to David. John Fryar et al. September 12, 1840, proved December 1845, New Hanover County North Carolina. McLeod File. This transaction may correspond to David's death.

Enoch's birth is fixed at 1815 from a source that says he died ":the 56th year of his age." Robert Bland, p. 56.

Jimmy Comer to Stephen Mcleod, November 8, 1982, shows Mary Bland, age 57, living with her son Robert C. Bland, in Sampson County.McLeod File.

Dates are based on Death Certificate of Lewis Bland Sampson County North Carolina, January 18, 1919 and Folder "The Bland Papers". McLeod File.

Death Certificate for Edgar Lee Bland, Sampson County North Carolina, March 9, 1948. The Death Certificate lists Edgar's birth date as April 6, 1881. McLeod File.

- (4) Mattie Tate Bland (April 13, 1888 January 10, 1964), married Walter White Peterson (September 28, 1881 March 10, 1945).
- (5) Luther Eugene Bland (May 29, 1890 April 21, 1959). Luther was born in Sampson County North Carolina. He married Addie Gavin, (October 10, 1893 December 4, 1956). Both are buried at Wells Chapel Cemetery. They had a single daughter:
 - (a) Addie Eugenia Bland (December 5, 1922), who married Robert Ray Smith (1922).
- (6) Mazie Bland (May 19, 1896 May 4,1951)
 married Allen David Johnson (February 27, 1888 May 5, 1947).
- B. Robert C. Bland (February 17, 1850 May 13, 1929).
 Robert Bland married Helen K. Stringfield (September 17, 1848 September 18, 1888). They had one known child:
 - (1) Robert James Bland (September 12, 1889 September 29, 1967). Robert married Ida Mae Cook on November 7, 1910. There was only one child by this marriage:
 - (a) Sidney Denziel Bland (August 29, 1911) who married Eva Mae Gurganious on September 2, 1932. Sidney moved to Salt Lake City Utah. They had three children.
- C. <u>Milton Gaston Bland</u> (C1854 December 1927). Milton lived in Wallace North Carolina. Milton married Nettie Hill (1872-April 9, 1931). They had a single child: 217
 - (1) Hubert Gaston Bland, (August 3, 1891 May 29, 1975)> Hubert married Elizabeth Catherine Wells (1890 June 1927) on January 5, 1908. They had two children:
 - (a) Annie Lee Bland (October 1, 1919) married Pearlie James Moore (1913-) on December 31, 1939.
 - (b) Ruth Elizabeth Bland (October 16, 1926 January 1929).

D. <u>David Luther "Luke" Bland</u> (January 30, 1860 - November 19, 1916). David married Dora A. Lee Jones, (August 29, 1869 - November 26, 1893) ²¹⁸. No information regarding children is available. David and Dora are buried at the Lee Family Cemetery in Duplin County.

These are the children of Enoch Bland and Mary Jane Lee.

- 13. <u>Timothy Bland</u> (May 29, 1818 September 1, 1883). ²¹⁹ According to Ann Bland Morris Timothy lived in a village called Goshen Creek, near Kenansville, North Carolina, in Duplin County. Timothy was described by an old timer who knew him as a tall man. A tintype of Timothy in Ann Morris' genealogy of his family shows a man with a somewhat outdated beard for the fashion of his day, a derby hat poised atop his great round head, with a very alert, intelligent expression. Timothy married two women including (1) Adline Ward, (May 7, 1825 December 13, 1861), on May 13, 1841. In the twenty years they were married Timothy and Adline had eleven children: ²²⁰
- A. Mary Elizabeth Bland, (May 13, 1842 February 19, 1905) Mary married Daniel Teachey (1834-1884) on January 12, 1860.
- B. <u>Samuel James "Captain" Bland</u>, (October 26, 1843 March 10, 1910). Samuel served during the Civil War with the CSA, I Company, 10th North Carolina Regiment, and though he served with the rank of private was known around Duplin County as "Captain." It is unknown whether he married and had children.
 - C. Frasanah Caroline Bland (September 5, 1845).

McLeod File, by Dora A. Jones, daughter of Milton and Susie Lee. "I joined the Baptist Church at Wells Chapel on Friday, the 18th day of July 1881. The ministers were D.W. Herring and W. B. Oliver. I was baptized on the third Sunday, the 21st of July 1884, in Black River, by W.B. Oliver. Never will I forget the fine sermons preached that week. They preached night and day. I was fourteen years old when I United with The Baptist Church at Wells Chapel.

I am taking as authoritative, Ann Bland Morris The Bland Family of Rocky Mount North Carolina (1977), Also useful is a long letter to Stephen McLeod from Mary L. Brown, December 16, 1981. She refers to Timothy as Romulus Timothy. McLeod file.

Timothy's Family is discussed by Robert Bland at p. 59. Major sources appeared in Ann Bland Morris, "The Bland Family of Rocky Mount North Carolina," McLeod File.

- D. William Jefferson Bland (October 25, 1847 October 25, 1918). Known among his friends as "Billy," William Jefferson Bland moved to the town of Willard in Pender County. One of his sons described him as a short, red haired man. He was a preacher for the Life and Advent Church. He was said to be a "medium preacher" meaning he preached not too loud and not too soft. Billy was said to have the power of divine healing and went on the church circuit healing bodies and saving souls. He died from kidney complications. William married three times, (1) Lucy Mallard who died two years after their marriage. There were no children by this marriage; (2) to Jane Lee, by whom William had two children:
 - (1) Tommie Attie Bland, (January 1, 1876 July 7, 1967). Those who knew him described Tommie Attie Bland, a minister, as a tall, stately man with beautiful white hair, soft spoken, quiet and very easy going, but a little long winded. 222 He married (1) Nancy Catherine Rivenbark (1878-1935) on March 10, 1897. In 1916, Tommie Attie and Nancy moved to Rocky Mount North Carolina. He operated a grocery store and barbecue business, but went bankrupt in the 1930s. Nancy died of a stroke in 1935. She and Tommie had six children:
 - (a) Susan Jane "Sudie" Bland (1897-) who married Needom Franklin English. They had two adopted daughters.
 - (b) Lily G. Bland (May 6, 1900 February 23, 1914).
 - (c) Samuel William Bland (March 12, 1902-January 7, 1966), who married Pearl Elizabeth Whitfield (1907-) in August 1928. They had one child, who was very significant for the family history of this branch. 223

Details below about William's marriage to Ann Giddens is found in Annie M. Teachey to Stephen McLeod, January 25, 1982, McLeod File.

²²³ Samuel William Bland and Pearl Elizabeth Whitfield's son Samuel William Bland, Jr. (April 14, 1929 -) married Faye Jennie Lawson. Their daughter Faye Annette Bland married Samuel Webster Morris. She is Ann Bland Morris, the author of the Timothy Bland genealogy.

- (d) Ruth Ellen Bland (June 2, 1905 1976) married Jesse James Barnhill (1902-). They had four children.
- (e) Lucy Adelaide Bland (October 16, 1907) married Randolph Cooper (1912-). They had two children.
- (f) Phoebe Bland (February 23, 1910) married Draton McKinley Jenkins (1898-1945). They had two children.
- (g) Annie Laura Bland (November 16, 1912) married Arnold Ray Brass (1907-1960) in 1933. Secondly she married William Doyette Murray (1911-
- (h) Herbert Daniel Bland (September 20, 1915 October 31, 1964) married Dorothy Virginia Moore (1918). They had three children.

Following Nancy Rivenbark's death, On April 9, 1939, Tommie married (2) Ella Ayers (February 16, 1896 - June 30, 1954), a woman who shared his passion for the ministry of God and traveled with him throughout Mexico and the United States. By the time Ella died, Tommie was 78, had seen a lot of the world and was doubtless finished with the parenthood game, but cashed in his chips for yet a third marriage, to Sarah A. Giddens.

(2) Callie Jane Bland (January 24, 1878 - July 30, 1960), who married James Leonard Mills, Jr. (1872-on February 19, 1896. They had eleven children.

Jane Lee died of breast cancer about 1879. William married a third time on October 4, 1880 to Sarah Ann Giddens (- February 2, 1909) and had six children:

(3) William Edward "Willie" Bland (August 15, 1881 - November 2, 1970). William lived his life in Willard North Carolina. He married on November 29, 1904, Sallie Blanton, (May 10, 1882 - February 12, 1963), and they are buried at Antioch Cemetery in Willard. In their life, Willie and Sallie were considered "poor but rich" and after her death, Sallie's grave was ransacked by someone searching for money believed to be buried with her. No children have been noted.

The dates given by Robert Bland, p. 59, seem problematic.

- (4) Emma C. Bland (June 2, 1883)
- (5) Robert Timothy Bland (April 21, 1886 June 8, 1973). A tough guy, Robert was a boxer and made a living by breaking oxen, like Mongo in Blazing Saddles. Robert moved to Wilmington and became a street car driver. He married Susan Ida Upgrove (September 3, 1904 October 1, 1973) on March 4, 1921. Tim and Susan are buried at the Antioch Church in Willard.
- (6) Jeff Bland (June 6, 1888 1951) who married Bessie M. _____ (1883-1947). 225
- (7) James Rufus Bland (June 20, 1892 February 26, 1970). At the time of his death, James was married to Lizzie Armstrong. James was buried at the Armstrong cemetery in Sampson County North Carolina. 226
- (8) Ailsie Sam Bland (March 31, 1897 -). Ailsie moved to Wilmington to work for a ship building company. He married Rebecca ____. In 1977, Ailsie and Rebecca had seven living children, William, Marjorie, Annie, Alberter, Callie, Barbara and Johnnie. Two of their children died.
- E. <u>Ann Victoria Bland</u> (April 3, 1849). Ann married Jessie Mills. They had seven children including a set of triplets.
- F. <u>Helen Frances Bland</u> (February 23, 1851 August 26, 1862).
- G. <u>Sarah Sylvania Bland</u> (November 14, 1852 January 2, 1937). ²²⁷ Sarah married a cousin, Harmon Bland, (1839-1924) (see above page 60 paragraph 2H) but there were no children.

A parent child relationship is assumed because of graveyard proximity to others in Tommie Attie Bland's family.

Death Certificate for James Rufus Bland, March 4, 1970. Sampson County North Carolina. The death certificate says James was 76 when he died.

Robert Bland established Sarah's birth as November 1, 1854 while VU, p. 319, lists her birth as November 14, 1852. Inasmuch as the 1854 date is an obvious impossibility, given its proximity with Edwin Jay Bland's birth, I am opting for the original listing in VU.

- H. Edwin Jay Bland (August 22, 1854 August 23, 1896).
- I. Cornelia Adeline Bland, (May 20, 1856) married Frank Lee. They had five children.
- J. John Clifton Calhoun Bland (March 2, 1858 September 9, 1862).
- K. Emma Estelle Bland (August 9, 1860 January 29, 1913). Emma died of cancer. She married Andrew Brown (1854-1931) on February 24, 1876. They had thirteen children.

Adline Ward died in 1861. Timothy may have served a stint in the Civil War for he next married Ala Bradshaw (July 12, 1836 - June 5, 1924), in 1865 or 1866. Timothy and Ala had a family of five children including:

- L. <u>Esther Isabella Bland</u>, (January 1, 1867 June 1, 1934). She married John W. Teachey (1861-1919). They had eight children. Ester is buried at the Carr Cemetery.
- M. Mary Jane Culbreth Bland, (July 24, 1868), Mary Jane married Sam Register and they had four children.
- N. Romulous Timothy Bland, (October 17, 1871 July 16, 1939). Romulus is buried at the Bland Cemetery. He married Sarah Elizabeth Bostic (June 19, 1874 October 17 1960) on November 24, 1904. They had six children:
 - (1) Edward Thomas Bland (September 19, 1905) who married Margaret Blanton (March 27, 1910 January 14, 1975). Edward and Margaret are thought to have had children but nothing further is known of them.
 - (2) An Infant who died in 1907.
 - (3) Davis Timothy Bland (August 11, 1908).
 - (4) Jimmie Norman Bland (September 14, 1910)
 - (5) Bertha Bland (May 24, 1912)
 - (6) Thelma Elizabeth Bland (February 25, 1914)
- O. <u>Jemima Bathsheba Bland</u>, (June 7, 1874 November 5, 1941), who married Joe Wood (March 20, 1876 November 4, 1947) on December 15, 1898. They had eight children.
- P. Bessa Newton Bland (January 20, 1877 September 4, 1949) who married David W. Johnson (October 12, 1880 September 19, 1967). They had four children.

These were the children of Timothy Bland and his wives Adeline Ward and Ala Bradshaw.

This concludes the family of Blands in New Hanover, Duplin and Sampson Counties, North Carolina, who descended from William Bland (C1748-1816) and his two sons, William Bland (1771-1854) and his wife Mary Parker and James Bland (C.1772-1818, twelfth generation) and his two wives, Jemima Alderman and Esther Newton. In an undertaking of such dimension, there are bound to be mistakes, both factual and conceptual. I would be glad to receive any corrections and to make amending notations in the next issue.

Miscellaneous Robert Bland found a woman named Elizabeth Bland (December 23, 1810 - February 7, 1892) married to Enoch Johnson (June 7, 1813 - June 1, 1885). If the dates are correct, she is not likely to be a daughter of James Bland and Esther Newton since their son James Thomas Bland was born December 30, 1810. She also is born too early to be a daughter of James Bland (1798-1862) and James father, William Bland (1771-1854) has a daughter Elizabeth born in 1802. Whose child is Elizabeth?

A similar question may be asked of Catherine A. Bland (June 26, 1862 - May 20, 1890). 229

A similar question may be asked about Katherine D. Bland (November 14, 1849 - August 20, 1906) married to Isaac Newton, (May 13, 1848 - May 18, 1895). 230
